2.4 Statement on Research (as in 2009)

My project is to develop Psychology into a discipline that takes culture, context and history seriously. I am a leading researcher in socio-cultural psychology of language and communication, which studies language as an activity that is situated socially and historically. I am the author of a seminal book, which pioneers a study of verbal hallucinations in this framework, of over 80 articles and a co-editor of five books.

My research has always been interdisciplinary - within Psychology, but drawing on Linguistics, Philosophy, Psychiatry and Sociology. I conduct the research in collaboration with academics from disciplines other than my own. Furthermore, my research strategy has been to conduct both basic and applied research, and to cross-fertilise the two. For instance, my work on the pragmatics of language has allowed me to produce original and sophisticated applied research on symptoms of schizophrenia and on learning disability; the applied work, on the other hand, focused my basic research and lent it a distinct flavour.

My basic research has always been on pragmatic properties of language, conceptualising it as a joint, social activity and a shared repository of knowledge. From this standpoint I have contributed to theories of social co-ordination, situated cognition, practical argumentation and situated categorisation. The problem I started with was how individuals coordinate with each other in multi-participant activities. I was concerned with how individual cognitive systems are made alike in socialisation, and with how coordination in specific situations is achieved despite individual differences. My research on reported speech and social identity in public argumentation elaborates my theoretical research on co-ordination and makes it concrete in a particular area.

My applied research has, over the years, been on dialogue in mental illness and learning disability. Recently I have focused on the relationship between symptoms of schizophrenia, and language. I have shown in a series of studies that the speech of individuals with different symptoms has different structural characteristics [14, 15, 18, 19, 23], but it is my recent work on pragmatics verbal hallucinations which is the most original. I have been able to determine many of their important properties by conceptualising them as 'inner speech with pragmatics' rather than as matters of perception. My work in this area has resulted in many journal publications [11, 13, 15, 20, 24, 28], and the recent influential book "Voices of reason, voices of insanity", and there is a substantial interest in my work on this topic both in academia and outside.

My strategy has been to establish international networks that would provide me with an optimal supportive environment in which to do my research and that would also help to distribute my research. In this I was successful - I was pivotal in establishing the three networks which helped me to increase my outputs. The networks are as follows.

This Network includes myself, Professor Wes Sharrock (University of Manchester), Professor Alan Costall (University of Portsmouth), Professor Jeff Coulter (Boston University), Professor Stuart Shanker (Toronto University) and Professor Ivana Markova. Under its auspices I organised an International Symposium 'Living without a theory of mind'. Producing Local Order, IIEMCA, Manchester, June 2003. My international research standing is evidenced by the above and by the following indices. I get invited to edit special issues of journals and to deliver invited papers to conferences. I am sought after as a reviewer of research proposals, book proposals and of submitted journal articles.

I also contribute significantly to helping the University to be an environment in which original scientific research is possible. This in the following ways:

- 1. <u>School of Psychological Sciences</u> I am a deputy leader of Language and Communication Research Group. I help my junior colleagues' and postgraduates' academic development in general and through holding weekly data analysis and theory groups.
- 2. <u>Faculty of Medical and Human Sciences</u> I served for two years on Faculty Promotions Committee and continue to serve on the Faculty Board.
- 3. <u>University</u> I am an active member of Senate as well as of the Board of Governors. I served as the president of the Manchester AUT and, at present, I am the senior vice-president on Manchester UCU, helping to create an environment conducive to carrying out original research.

3. Teaching

3.1. The past

Postgraduate Teaching

Cognitive Science Program (MSc)

My major educational achievement at Manchester University was to establish the Cognitive Science Program. This involved designing a coordinated interdisciplinary syllabus, which was accepted by both the University and the funding bodies as exceptional. I designed and directed two core psychology modules (Psychology of Language, Communication and Activity" and "Topics in Human Cognition"). The course run between 1986-1996 and in its heyday was awarded 11 research studentships from relevant research councils.

Undergraduate Teaching

My undergraduate teaching in Manchester has been versatile; over years I taught courses in very different areas of Psychology, including those on Thinking and Reasoning, Psychology of Language, Psychopathology, and History of Psychology.

3.3. Statement on Teaching

I enjoy teaching, and not only to convey given knowledge to the students. I indeed do this in my lectures, and in a wide range of psychological areas, which include language and communication, reasoning and argumentation, abnormal conduct and experience, history of psychology. I do, however, find particular satisfaction in helping psychology students to learn to think rigorously, and critically. This is reflected in the argumentative structure of my lectures and, as a result, students find them interesting, and intellectually challenging. The contemporary resource problems in higher education and the increasing student staff ratios, however, mean that my stress on developing the quality of thinking in students requires a recourse to innovative methods of teaching.

I am in particular partisan to using problem based approaches and structured small group teaching methods to achieve my teaching aims. I feel very much at home teaching at postgraduate level and enjoy postgraduate teaching and research supervision.

4.3. Statement on Administration and Management

I find administration and management easy, and do it in an efficient, collegial and constructive manner. This requires skills, which I acquired at both Departmental and University levels, but also in my involvement in the Association of University Teachers (AUT) as its president and personal case coordinator.

My major administrative achievement in Manchester has been to partake in establishing and managing the cognitive science program. This was a task which required much thought, and effort and involved inter-disciplinary cooperation at the Faculty of Science (Departments of Computer Science, Psychology, Medical Biophysics) as well as between Faculties (Departments of Linguistics, Philosophy, CCL - UMIST). I was pivotal in obtaining the funding for the course (14 studentships). I was the course director for several years and during this period Manchester became one of the three top centres for studies in Cognitive Science in the UK, recognized and financially supported by SERC, DENI and the British Council, with considerable overseas student intake.

Being the program director was a major administrative duty, involving admissions, publicity, examinations, as well as day-to-day management.

Recently I have been involved in essential departmental activities, such as preparation for the RAE, and I am the departmental staff development officer. This involves both formulating the individual strategies optimal to achieve colleagues probation, promotion as well as preparing their cases for faculty review committees, and co-representing them in these committees. I have been reasonably successful in all these, thereby contributing to the positive atmosphere in the department.

At the University level I have served on the Senate as an elected member for many years and was a member of its Nominations Committee. I am also an elected member of the Court. I served as a member of the Interim Academic Committee, an academic body pivotal in the merger of UMIST and the University of Manchester.

During my involvement with the MAUT, I have been its president and senior vice president, and for several year I have managed MAUT's dealing with personal cases. These tasks provided me with intense experience of the University of Manchester, its institutions and people, and with essential management and administrative skills. It is likely that next year I will serve again as the President of the Manchester Association of University Teachers.

During the past two years I have been elected member of Faculty Committee and Faculty Promotions committee. I ceased to be a member of the latter following my promotion. I have however been elected to Senate and the Board of Governors where I serve on Risk Committee.
